

ForeFlight "Fly Out" Sweepstakes

OFFICIAL RULES

Promotion begins on April 1, 2021 at 8:00am (Eastern Standard Time) and ends 11:59 p.m. (Eastern Standard Time) on July 31, 2021. All entries must be received during the Promotion Period to be eligible.

Upon conclusion of Promotion Period, a prizewinner will be determined by a random drawing from all eligible entries to be held by Sponsor on the last day of the contest July 31, 2021 (each a "Winner").
